- length of delay for your child's classroom district.


Note: When there is a three hour delay, class time will be extended by one hour at end of day.

#### **DRESS CODES**

The purpose of a dress code is to insure a proper learning environment. Parents and student are trusted to remember that school is a place of learning and not a showroom for extremes of dress and grooming. In general, school dress and appearance should be such that it does not cause disruption or threaten the health or safety of the students. Attempts by students to call undue attention to themselves by inappropriate, unusual or bizarre dress, hairstyle, hair color or visible body piercing objects shall not be permitted.

- 1.) Hair must be neat, clean, out of the eyes, and well-groomed.
- 2.) Dark glasses may NOT be worn in school except under doctor's orders.
- 3.) Hats, headgear, bandanas, headbands, hoods, etc., are not permitted to be worn in school.
- 4.) All shirts, tops, blouses or dresses must cover the shoulders. Strap tops, tank tops and cut-off T-shirts are NOT acceptable for school wear. Tops must have a minimum of capped sleeves and either be tucked in or overlap the pants or skirt the student is wearing.
- 5.) Appropriate undergarments must be worn and are not to be seen when standing still, sitting, bending or raising your arms.
- 6.) Shorts are acceptable but must be the pocket type shorts. Biker shorts, cheer shorts, or any tight fitting shorts are unacceptable. Minster and New Bremen classrooms are only permitted to wear shorts of mid-thigh length or longer from April 1 through October 31.
- 7.) Shoes or sandals for the feet must be worn at all times.
- 8.) Pants must be worn at hips or waist.
- 9.) No long wallet chains will be allowed, nor choker chains of excessive length.
- 10.) Clothes that are ragged, torn, have excessive holes, have offensive language, phrases, gestures, or innuendoes, promoting alcohol, drugs, tobacco, Satanism, and/or any unacceptable social and moral behavior are NOT permissible. Interpretation of such material is at the discretion of the school administration.

The administration reserves the right to make judgments and decisions regarding "appropriateness and acceptability" of all clothing.

This is a general dress code for all school districts. However each school has its own unique set of rules that may vary by building. Please check with your student's classroom teacher for complete listing of acceptable and unacceptable dress. If in doubt about an outfit, bring a change of clothing or do not wear it at school. District administration may choose to send the student home.

#### STATEMENT OF SPECIAL EDUCATION PHILOSOPHY

#### PHILOSOPHY OF EDUCATION

Although the Constitution of the United States has vested each state with the responsibility of providing for an educated citizenry, the federal government has enacted legislation, either directly or indirectly, which affects education. This sphere of influence, combined with the Ohio Legislature's felt moral, as well as legal, responsibility for providing an education, in accordance with its own Constitution, prompts the belief that all schools in Auglaize County should:

- 1. Adhere to all federal laws, rules and regulations, and guidelines that enhance, encourage, maintain, or promote educational programming and resultant funding.
- 2. Operate in accordance with all state laws, opinions of the Ohio Attorney General, and standards as interpretations of the law by the Ohio Department of Education.
- 3. Elect and maintain a local Board of Education to formulate policy for efficient control of educational activity at the community level.

We further believe that each of the Auglaize County Schools should:

- 1. Organize and administer each school to meet the academic and non-academic needs of the students and community in which it operates.
- 2. Determine each student's level of academic and/or non-academic performance and plan instruction within the limits of the student's capabilities.
- 3. Plan co-curricular and extra-curricular activities to include the gifted students and those students classified as "special".
- 4. Work closely with the home, church, and other community agencies to reinforce and implement attitudes and values conducive to the perpetuation of American culture.

We believe that the aforementioned goals will tend to promote objectives concerned with:

- 1. Developing intellectual curiosity and responsibility.
- 2. Providing those qualities necessary for functioning productively in a changing world.
- 3. Developing each pupil to his/her maximum ability.
- 4. Fulfilling the potential of each for being good citizens in a democracy.

#### **ABSENCE and/or TARDINESS**

Ohio's Missing Child Law now requires schools to make every effort to contact parents of absent students. Parents of absent students are to call the child's teacher on the morning of <u>each</u> day their child will be absent, using the direct phone lines within each classroom, by 9:00 a.m. Parents not having called the school will be called at home or at work to comply with the Missing Child Law. If no parent contact is made, the student, upon returning to school, <u>must</u> bring a note signed by the parent giving reason for the absence.

It is the duty of the Auglaize County Educational Service Center to enforce the compulsory attendance law. Students will be allowed five (5) days of excused absences per nine (9) week grading period. Any absences over five (5) days without a physician's excuse or administrative permission are unexcused. (EXCUSED OR UNEXCUSED DECISIONS ARE MADE BY THE ADMINISTRATION.)

#### WHAT CAN BE EXCUSED? Excused absences are:

- A. Personal illness or medical and/or dental appointments.
- B. Family illness requiring student's presence at home.
- C. Death or funeral of a relative or close friend.
- D. Religious holidays.
- E. Emergency requiring student's presence at home.
- F. Vacation with family or school visitation with prior approval.
- G. Farm work on farm of parent or guardian that is prearranged through Supervisor.
- H. Required work at home due to absence of parent with prior approval.

#### WHAT CANNOT BE EXCUSED? Unexcused absences are:

- A. Oversleeping and/or alarm not working.
- B. Car trouble.
- C. Appointments that can be after school.
- D. Vacations without prior administrative approval.

An unexcused absence is not only a violation of school regulations but also State Law, and therefore must be considered as an act of truancy.

#### **TARDINESS**

Tardiness to school will be reported to the attendance office. Tardiness to a class during the school day will be handled by the individual teacher. Students habitually late to class shall be sent to the office and a discipline report will be sent to the parent or guardian.

Students tardy (per nine (9) week grading period) may receive the following: tardy 2-6 = detention; tardy 7-9 = one or more Monday/Saturday schools; tardy 10 or more = progressive suspension.

#### SICK CHILD'S RESPONSIBILITIES

Your child's classroom is one in which there is high interaction between students and staff. Consequently, viruses and communicable diseases spread rapidly. To help keep illness under control, we ask parents for your cooperation.

Do <u>NOT</u> send your child to school with the following:

- \* Diarrhea
- \* Conjunctivitis
- **★** Vomiting
- **★** Untreated infected skin patches
- **★** Unusual spots or rashes
- \* Sore throat or difficulty in swallowing
- **★** Difficulty or rapid breathing/ respiratory infections
- **★** Elevated temperature of 100° F or higher
- \* Stiff neck
- \* Extreme fatigue due to medical reasons such as seizure activity, medication, etc.

Our medication policies are firmly enforced.

- A. We will give medication only from its original container which is from a prescription written by a licensed physician specifically for a child.
- B. In order to be aware of who gets what when, a parent must fill out our MEDICATION FORM and hand it directly to the child's teacher.
- C. We will <u>NOT</u> give non-prescription medication unless accompanied by a note from a physician stating specific dosages for a specific child, including all over the counter remedies.

If a child becomes ill or is injured during the day or is suspected of having a communicable disease, he/she will be isolated and attended by an adult until the parent or responsible person is contacted by telephone and arrives to take the child home. Children must be free of fever for at least 24 hours before returning to school. Please contact the school if your child has a contagious illness/head lice so that the other parents may be alerted.

# **School/County Health Lice Control Policy**

- 1. The school health nurse or other designated school official will confirm suspected cases brought to our attention by school personnel or family and notify the family via phone call or personal contact of this confirmation.
- 2. The school health nurse or other designated official will strongly recommend that the parents/guardian check themselves, siblings and anyone else living in the household. It is necessary to treat all infested household members.
- 3. Instruct the families in proper treatment (including the use of olive oil and limited use of treatment kits) and method of dis-infestation. In addition, the school health nurse or other designated school official will inform parents as to where the supplies can be obtained.
- 4. After treatment, families will then be required to report to the County Health Department or other designated place for follow-up in accordance with the Health Department's procedures.
- 5. The Health Department will notify the school with the results of the examination(s) through a signed form.
- 6. The Health Department will require families to be essentially nit free for two consecutive weeks before releasing them from follow-up.
- 7. After approximately five school days, if little to no improvement in the condition is shown; the family will be notified during a routine appointment at the Health Department that a letter will be sent to the Prosecuting Attorney.
- 8. If the family continues to show little or no cooperation, or if there is a serious lack of effort among family members, the Health Department will refer the case to the Prosecuting Attorney's Office and Children's Services will be notified.

The development of this protocol was a collaborative effort between the Auglaize County Family and Children First Council, the Auglaize County Health Department, Auglaize County Prosecutor's office, and Auglaize County schools. In order for the protocol to be effective, it requires the cooperation of all involved agencies. If agencies fail to adhere to this protocol, it could result in lack of assistance from county agencies.

# Schools Don't Get Head Lice – People Do!

Anyone can get head lice. They affect approximately 12 million Americans each year, mostly children. While an infestation is not life-threatening, it is easily spread from person to person and is a frequent problem in schools. Lice must have human contact to survive – they do not live on desktops, in books or papers, or on floors. Schools keep children who have head lice out of class so that the infestation will not be transmitted to other children.

Your schools, Health Department, and other service agencies are working with you to help keep your child free from head lice. The most important partner in this process is YOU – the parent. You are ultimately responsible for assuring that your child does not miss school because of head lice.

All schools in the county will follow the same policy and procedure in dealing with head lice. If your child is found to have signs of infestation while in school, the following steps will be taken:

- School personnel will contact you and suggest methods and products to help you get rid of the lice.
- School personnel will re-check the child's head within one week to make sure that treatment is working.
- If no progress in removal of the lice is observed within that week, you will be referred to the Health Department for consultation and follow-up in the Health Department clinic.
- If no progress is observed within several weeks of follow-up, the Health Department will refer the case to the Auglaize County Prosecutor for possible action.

If you have questions about school policies and procedures, contact the principal in school building of attendance or program supervisor. If you have questions about head lice and treatment, contact the Health Department at (419) 738-3410.

## Frequently Asked Questions about Head Lice

#### What are head lice?

A head louse is a reddish-brown, wingless insect about the size of a sesame seed (-). It lives only on humans and must have human blood as its food source to survive. **Nits** are the eggs of head lice. Oval-shaped and whitish-gray in color, they are firmly attached to individual hairs close to the scalp. Diagnosis of head lice, or pediculosis, is usually made by finding nits not adult lice.

## How do people get head lice?

Head lice migrate from person to person through head to head contact or through sharing of personal items such as brushes, combs, hats, and pillows. Lice do not hop, jump, or fly! People do not get infested

due to poor personal hygiene or because their home is dirty. Pets do not carry head lice. Lice do not live in grass or trees.

## How can I tell if my child has head lice?

Watch for frequent head scratching. Persistent itching, particularly around the ears, crown, and back of neck, is the most common symptom of infestation. However some people never itch at all. The most reliable method is to check your child's head regularly for the presence of nits.

## How do I treat head lice infestation?

Getting rid of head lice is a three step process:

#### 1. Kill the live lice.

Many people first try a lice-killing shampoo or crème rinse that can be purchased without a prescription at most drugstores. *These products contain pesticides and must be used very carefully!* Check with your doctor or pharmacist and follow directions precisely. There are many recent reports of lice being resistant to these drugs. If one application does not work, do <u>not</u> use it again. The lice still will <u>not</u> die and the chemicals could be harmful to your child. Do not use kerosene, gasoline or lye soap!

Olive oil, used alone or in addition to lice-killing products, has been reported to be effective in killing lice and to aid in the removal of nits. You must apply the oil correctly and the treatments must be timed to disrupt the life cycle of the louse. Olive Oil is non-toxic and any excess left in the hair can be easily removed by using a regular shampoo.

#### 2. Check for and remove all nits.

In bright light (a magnifying glass may help) separate the hair into small sections. Nits are attached to the hairs at an angle and are usually within one-half inch of the scalp. Use a lice comb, your fingernails, or baby safety scissors to remove <u>all</u> attached nits. Applying olive oil or vinegar may make nit removal easier. This step should be done <u>daily</u> until there are no more nits. While it is tedious and time-consuming, it is the most important and effective part of the treatment.

#### 3. Clean the home environment.

Clothing, bed linens, and washable toys should be washed in hot water and dried for 20 minutes in a hot dryer. To remove lice or loose hairs with attached nits from furniture, rugs, car seats, and any item that can't be put in a dryer, vacuum thoroughly. Stuffed animals and throw pillows that cannot be washed should be vacuumed and kept sealed in a plastic bag for 10 days. Brushes and combs may be soaked for 10 minutes in hot (not boiling) water. Bug sprays can be dangerous and are not recommended.

When you have completed these three steps, it should be safe to send your child back to school. After continuing to check for and remove nits over a three-week period, your child should be free of lice. Time, effort, and persistence on your part will pay off!

In an effort to keep all lines of communication open between school and home, classroom teachers will send home notebooks daily for comments, concerns, and daily happenings. All parents/guardians are encouraged to write in student's notebooks each day. Information provided by the parents is often helpful for teachers to understand your child's feelings, moods and general disposition each day. We feel the notebooks are an effective tool to keep parents and teachers in constant contact with each other.

In addition to the individual notebooks, each classroom will be sending home monthly newsletters. These newsletters inform you of classroom happenings, schedules and events. Please take the time to read and discuss these newsletters with your child. These newsletters provide you with valuable information about your child's classroom, as well as allowing him/her to enhance and practice their communication skills.
